- The Dean, HoD & Course Coordinators of the Department, School of Law will be informed to circulate the Time Table, Schedule of Classes to the I year and II year of 3 years LL.B (Hons) Degree courses and 5 years (Hons) Integrated Degree courses and III year and IV year of 5 years (Hons) well in advance along with the Academic Calendar.
- The Dean, HoD & Course Coordinators, School of Law will ensure that regular classes are conducted as per the schedule.

- Parents are requested to advise their Ward to attend the classes regularly.
- An Undertaking is to be given by the Students & Parents to the effect that the students will not involve in any indisciplinary activity and shall abide by the Rules & Regulations of the Institution. Failure to adhere the Rules & Regulations shall be viewed seriously and severe action shall be initiated against such students with maximum punishment of issuing TC based on the recommendations of the Enquiry / Disciplinary Committee.
- Students are also instructed to pay the Tuition Fees and other fees for the I year and II year of 3 years LL.B(Hons) Degree courses and 5 years (Hons) Integrated Degree courses and III year and IV year of 5 years (Hons) on or before 07.02.25 the last date as notified. Any pending fees dues should also be cleared immediately, without which students will not be permitted to attend the classes.
- The Parents and Students are required to contact the Mentors regularly and monitor the performance including the Academic activities and Attendance particulars etc. via BIHER ERP PORTAL.
- In addition to regular classes, Special Lectures, Moot Court, Legal Aid Camps, Court Visits, Conferences, Seminars are regularly conducted. Therefore, the students are required to attend these programmes and update their latest knowledge.
- The students are also instructed to attend the Internship Training Programmes as per Bar Council of India (BCI) norms and the Mentors will verify the Internship Certificates before commencement of University Examinations.
- > It may be noted that as per Bar Council of India/ BIHER norms, 75% attendance is mandatory to appear for the University examinations.
