In the realm of research, Prof. Dr. Gopal's mentorship has been transformative for 10 Ph.D. scholars—five of whom have successfully completed their Ph.D., dissertations—along with overseeing 50 M.L thesis. His contributions to legislative drafting are noteworthy, including his involvement in the Tamil Nadu Tapioca Development Act, 2013, and a comprehensive review of the Tamil Nadu Buildings (Lease and Rent Control) Act, 1960.

Prof. Dr. Gopal's engagement with the legal fraternity is extensive, having presented numerous papers at national and international conferences on a wide spectrum of subjects, such as environmental law, human rights, and sustainable development. He has organized and presided over multiple seminars that addressed critical issues like climate change, disaster management, and biodiversity conservation by organising 20 National including 2 international conferences and also edited two books.

His scholarly output includes profound analyses on topics like environmental justice, water resource management, and the legal contours of contempt of court in India. His active participation in workshops and refresher courses has further enriched dialogues on urban land governance, humanitarian law, and cyber legislation, solidifying his reputation as a preeminent scholar in the field of law.

At Bharath Institute of Law, Prof. Dr. Gopal has been a strong advocate for student welfare, actively engaging with students to enhance their academic experience and professional skills. He has fostered a nurturing environment by facilitating various workshops, legal aid camps, and moot court competitions at national level.
